We are able to see the score from 1 to 5 (paws) on each pet profile received. \* Pet owners are not able to see the score.

**Score factors**: Breed, Weight, Vaccination Details.

• 1 Paw: highest risk for that pet; 5 Paws lowest associated risk for that pet.

There are no scores for Assistance Animal, only Recommended or Not Recommended.



0 paws: Not allowed unless ESA.

1 paw: not approved \* \$65.00 /month.

2 paws: not approved \* \$55.00 /month.

\* Exception case by case: If 1-2 paws approved, there is a one-time pet fee added, the fee amount is case by case as well. "Bully breed" dogs not approved, unless they have proper training certificates (Nebraska Humane Society),

3 paws: \$45.00 /month

**4 paws**: \$35.00 /month

**5 paws**: \$25.00 /month





#### **MANAGEMENT**

Our Property Managers are Licensed Real Estate Agents who exclusively manage properties. This results in greater oversight and higher portfolio profitability.



### **SCREENING PROCESS - AA CLASS**

### **CLASS AA PROPERTY**

- All applicants must have a credit score > 700
- No negative credit items allowed.
- We will have to run a **social security number.**
- Rental verification- must be an institutional landlord, canceled checks or copies of money orders.
- Your income will have to be 4 times greater than the rent.
- No Cosigners allowed.



### **SCREENING PROCESS - A CLASS**

### CLASS A PROPERTY

- All parties must have a > 650 credit score.
- Credit scores down to 600 are considered with an institutional landlord reference.
- No past due credit balances > \$2500
- We will have to run a social security number
- Rental verification must be an institutional landlord, canceled checks or copies of money orders.
- Your income will have to be 3 times greater than the rent.
- Cosigners are accepted for credit only. Combined income must be 5 times the amount of rent when using a cosigner.



### **SCREENING PROCESS - B CLASS**

### CLASS B PROPERTY

- Primary Applicant needs a credit score > 600
- Credit scores down to 550 are considered with an institutional landlord reference.
- No past due credit balances > \$2500
- We will have to run a **social security number.**
- Rental verification- must be an institutional landlord, canceled checks or copies of money orders.
- Your income will have to be 3 times greater than the rent.
- No Cosigners allowed.



### **SCREENING PROCESS - C CLASS**

### CLASS C PROPERTY

- No past due credit balances > \$3500
- We will have to run a **social security number**.
- Rental verification- must be an institutional landlord, canceled checks or copies of money orders.
- Your income will have to be **2 1/2 times greater than the rent**.
- No Cosigners allowed.
